Dear fellow members,

As you all are aware during the last AGM of the society held on 20th September 2025, it was decided to conduct election for the management committee in April 2026. Accordingly, an election committee was constituted.

Subsequently based on MOM the meeting of the management committee held on 24th March 2026, Mr. Lokesh, Secretary issued a formal order vide letter dated 31st March 2026 for putting in action the desired election process by three members -

1. Rajesh Rai
2. Anil Jain
3. V.S. Mehta.

Election Committee after its meeting has given necessary directions and guidelines to be followed through letter dated 2nd April 2026.

The management committee has thus announced elections on 19th April 2026, after the EGBM on the same date.


Now, pursuant to issue of letter announcing elections on 19th March, 2026 the election committee would like to reiterate following in this matter:-

1. Nominations to be filed by **12th of April 2026**. 12th being Sunday society office will be closed however, one supervisor will be available from 10 am till 5pm in the society office to collect the nomination form.
2. Withdrawal of nomination by **16th of April 2026**,
3. On **17th April 2026**, nominations will be checked and the nomination found in order will be signed by election committee member Shri. Rajesh Rai and accordingly a list will be prepared of candidates in fray, which will be sent to all the members.
4. Nomination papers had been mailed to all and can also be collected by any member from the office of facility manager during working hours that is from **10:00 a.m. to 5:00 p.m.** It can also be downloaded from website of society.

5. The elections will be held for the following posts:-
 - a. **President**
 - b. **Vice President**
 - c. **Secretary**
 - d. **Treasurer**
 - e. **Joint Secretary**
 - f. **2 Executive Members**
6. All members participating in the elections will be given set of ballot papers.
7. After marking the ballot papers the same should be deposited in ballot box(s), which will be placed at the venue. Kindly note that the election process will start immediately after 1:30 PM, the EGBM is concluded and the platform given to the election committee will continue up to 5:00 PM.
8. Counting will be done thereafter on same day. You are free to witness and /or join in the counting process, if required.
9. This is first time elections are being conducted in this manner since the formation of society in 2013, it is therefore desired that maximum number of members may join.

This committee looks forward to continued cooperation of all members, management committee and facility manager and his team to ensure smooth and successful conduct of elections.
